Dear Property Owner:

To change the classification on a property in Maricopa County, please complete items 1-7 on the **Taxpayer Notice of Claim - Real Property** form. More information can be found on our website at mcassessor.maricopa.gov. Navigate to Departments/Notice of Claim. Tips for filling out the form:

- Item 1: Enter the COUNTY and the PARCEL ID Number (Account Number is not required).
- Item 5: Include the reason for the change in legal class and the date the change occurred.
 - Tax Year: Enter each year the classification needs correction. Per A.R.S. § 42-16256, the current year and a maximum of 3 prior years may be corrected.
 - Property Class: Include the current class and the proposed class (see below).
 - Other fields: Not required to change legal class. Entering N/A is acceptable.
- Item 6: Enter your name/address/number and include if you are the Owner, an Agent, or an Attorney for the property.

Acceptable Supporting Documentation (Required for all Legal Class 3)

Please submit at least one of the following:

- Driver's License with resident's name, residence address, and issue date reflecting when residence started.
- · Voter Registration Card with resident's name, residence address, and issue date reflecting when residence started.
- Tax Document with resident's name, address, and tax year only **AND** a Motor Vehicle Registration or utility bill (gas, water, electric).
